- o EWD Photography may substitute another photographer to take the photographs in the event of Studio/Photographer's illness or of scheduling conflicts. In the event of such substitution, EWD Photography warrants that the photographer taking the photographs or video shall be a competent professional.
- o Balance must be paid in full prior to or on wedding date before any photos are taken.
- o The EWD Photography reserves the right to use negatives and/or reproductions for advertising, display, publication or other purposes. Negatives and previews remain the exclusive property of EWD Photography.
- o Upon signature, the EWD Photography shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, unless the Studio is able to fully replace the cancelled reservation, all deposits are non-refundable, even if the date of the wedding is changed or the wedding is cancelled for any reason.
- o If the EWD Photography/Photographer's cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the EWD Photography shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the EWD Photography/Photographer's fails to perform for any other reason, EWD Photography/Photographer's shall not be liable for any amount in excess of the retail value of the Client's order.
- o Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases EWD Photography/Photographer's from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
- o The charges in this Contract are based on the EWD Photography/Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
- o NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs or videos elsewhere without EWD Photography/Photographer's permission, and violators of this Federal Law will be subject to its civil and criminal penalties.
- o This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
